# Aquinnah Public Library Library Board of Trustees Minutes – Thursday, April 28, 2022

#### Meeting convened 2:05 PM

<u>Present</u>: Kathie Olsen, Trustee; Margie Spitz, Chair; Rosa Parker, Library Director. Trustee Heidi Vanderhoop joined the meeting at 2:30.

<u>Review of Minutes</u>: Minutes of March 24, 2022 approved unanimously.

## Old Business

- <u>Strategic Plan</u> update: Report from Michelle Eberle, Massachusetts Library System consultant, on the Strategic Planning Community Forum has been received. As follow-up:
  - Margie will contact the Friends of the Library and ask them to write to Forum participants inviting them to join the Friends of the Library.
  - The timeline for development of the Plan is:
    - Rosa will draft Strategic Plan goals and hand out to the Board of Trustees at the <u>May</u> meeting.
    - A draft of the full Plan will be presented to the Trustees in <u>August</u>.
    - Board of Trustees approve the final Strategic Plan at the <u>November</u> meeting.
    - Strategic Plan is to be done by <u>December</u>.
- <u>Library Parking/Walkway Project</u>: Rosa reported that of the three contractors suggested, only one had responded to her query, and they said they could not help. Heidi requested that Rosa call the others and ask them to come and look. Rosa will call again. Kathie expressed her frustration with the urgency of the situation and the length of time it is taking to make any progress.
- FY23 Budget:
- <u>Little Free Library</u>: Still waiting for the Town crew to have time to install the Library. It is fully painted and ready to install. During discussion it was requested that Rosa purchase two weather-resistant picnic tables for the outside area, as authorized last summer.

#### New Business

- <u>By-</u>Laws: Discussion of proposed By-Laws was postponed until the next meeting.
- <u>Financial Report</u>: Budget has been submitted for the Town Report (a copy was sent to the Trustees with the Agenda). All agreed that a monthly meeting with the Town Accountant was needed to provide the Library Director and the Trustees with updated and correct information on expenses charged to the Library.
